


图 1. 封装概览




图 2. 俯视图




图 3. 内部框图




图 4. 开关时间的定义




图 5. 内置热敏电阻的 R-T 曲线





图 6. 平面度测量位置




P1:正常工作: IGBT 导通并传导电流。





图 9. 应用实例
